## Connecting communities with SH 99 Grand Parkway

Since breaking ground in July, construction is progressing for Segments F-1, F-2 and G of the Grand Parkway in Harris and Montgomery counties to meet the transportation needs of one of the fastest growing areas in the U.S.

To accomplish the task, the Texas Department of Transportation selected Zachry-Odebrecht Parkway Builders for one of the largest designbuild projects of its type in the country. In addition to designing and building the highway, Zachry-Odebrecht also is managing right-of-way acquisition. Read about the Zachry-Odebrecht Right-of-Way team on pages 3 and 4.

State Highway 99 from US 290 to US 59/I-69 North will be completed in late 2015. The outer loop system will give motorists more direct travel options through and around the region. ## Officials, public celebrate long-awaited project with groundbreaking

To appreciate the tremendous cooperative effort it takes to make State Highway 99 Grand Parkway a reality, just look at the diverse list of speakers and attendees at the groundbreaking ceremony for Segments F-1, F-2 and G.

Hosted by the Texas Department of Transportation and Zachry-Odebrecht Parkway Builders, the July 23 groundbreaking drew a number of state and local leaders and transportation officials who spoke to a crowd of approximately 300 attendees.

The event was held at Springwoods Village overlooking the future Grand Parkway Holzwarth Bridge. In partnership with Coventry Development, the usually secured site was opened to guests for the groundbreaking ceremony.

As part of the celebration, North Houston Association hosted a luncheon that drew its largest crowd ever - approximately 500 people. The association identifies, advocates and supports projects and initiatives that advance business and improve the quality of life in North Harris and Montgomery counties.

Speakers at the events highlighted the project's importance to Harris and Montgomery counties, one of the largest growth areas in the United States.

### *Mission Possible: Getting right-of-way for 450 parcels without delay*

Zachry-Odebrecht Parkway Builders' assignment from the State of Texas? Acquire approximately 450 privately owned parcels while designing and building a 38-mile stretch of the Grand Parkway – all in just over two years.

Obtaining rights-of-way can be a lengthy, complex process. To accomplish their mission, Zachry-Odebrecht Right-of-Way (ROW) Manager Vic Rosen and his team have been working diligently – and sometimes thinking outside the box – to secure the needed rights-of-way, totaling almost 2,200 acres.

Zachry-Odebrecht signed the contract with the Texas Department of Transportation (TxDOT) in March to design and build Segments F-1, F-2 and G for State Highway 99 Grand Parkway in Harris and Montgomery counties. Zachry-Odebrecht is also managing the right-of-way acquisition process for TxDOT. To open these segments by the late-2015 deadline, the ROW team is securing rights-of-way while other teams design and build sections of the highway.

Rosen said, "Accomplishing these tasks in parallel fashion is a relatively new concept for Texas. The SH 99 Grand Parkway could possibly be one of the largest right-of-way acquisition design-build projects of its kind in Texas and the U.S."

#### Being fair, open, consistent

"TxDOT set the route after extensive review and public input," Rosen said, "so the 400-foot-wide corridor is a given." The segments also encompass five major intersections, which require additional acreage. "We can't stray from that route, but as we negotiate we want to be fair, open and consistent with all landowners. We want to understand their needs and do everything we can while working to expedite the process. We can't afford to waste a minute."

As one example of finding creative ways to save time, TxDOT ROW team members, who review and approve the agreements, work in the Zachry-Odebrecht office in north Houston rather than the TxDOT office near downtown.

"Instead of an 80-mile round-trip drive to downtown Houston, we have a 32 ½-second walk down the hallway. It really speeds up the discussion and decision-making process. As far as I know, this is a first for TxDOT to co-locate with a contractor on a project of this size and urgency," Rosen said.

As another example, the ROW team is seeking possession and use agreements when TxDOT and landowners can't agree on an offer amount. The agreement gives Zachry-Odebrecht access to the parcel while it continues through the lengthy eminent domain process.

#### **Tremendous progress**

Rosen's team is making great progress. They have completed almost all surveys, have sent offers for almost three-quarters of the parcels to the landowners and are currently closing on properties. If landowners do not accept the appraisal-based offer, those parcels move forward toward the eminent domain path, a process that Rosen said can take several months. (See The Process, page 4)

#### It's complicated

Rosen said that each of the parcels and its owners offer a unique set of circumstances. Parcels range in size from single residential lots to 100 acres. Some landowners are commercial developers ready to take advantage of the economic growth and others want to hold on to rural property.

"No two are identical. Our job is to get to know the owners to understand their issues and work with them within the boundaries we've been given," Rosen said.

When Zachry-Odebrecht found that fourthgeneration rancher Russell Klein had a pasture lease on one of the parcels, the team worked with him to make it easier to transfer his 40 head of cattle and equipment to other property.

Klein, of Tomball, said, "They've been great to work with and they do what they say they're going to do. You can't ask for more than that."

#### The Process

- **Appraisal** Property appraisals are made and TxDOT agrees to the valuation.
- Offer An offer is made to the property owner who may accept, counter or reject the offer. TxDOT may accept or reject the counter offer.
- Sale or eminent domain If the offer is accepted, the landowner sells the property to TxDOT. If the property owner rejects the valuation offer, the property is then classified as eminent domain and is settled through further negotiations or court proceedings.
- Negotiation The landowner can pay for an independent appraisal and hire an attorney to negotiate terms of condemnation.
- Appeals Before properties are condemned, landowners may appeal to a special commission that will determine the amount of money to be awarded. If a landowner disputes the award, he or she can request a trial by judge or jury.
- Possession and use agreement To move the project forward, in some cases the landowner and TxDOT sign an agreement in which the landowner receives 90 percent of the initial offer and gives TxDOT access to the property while both parties continue through the eminent domain process.

## Association paving the way for Grand Parkway

While construction on a 38-mile section of the State Highway 99 Grand Parkway has just begun, the Grand Parkway Association has been paving the way since the early 1980s. The Texas Department of Transportation (TxDOT) created the non-profit state transportation corporation in 1984 to facilitate development of the proposed 180-mile-plus scenic highway known as the Grand Parkway.

Executive Director David Gornet explained that the association lays the groundwork for construction of the 11 sections that will make up the Grand Parkway. Responsibilities include public scoping meetings, public hearings, preliminary engineering and environmental studies to determine the path of the parkway before getting federal approval.

The association operates on funds received from various sources including TxDOT; Houston METRO; and Harris, Fort Bend, Chambers, Galveston and Brazoria counties.

Gornet said that completion of the entire Grand Parkway depends on financing and demand.

"As the area grows and more development takes place or if traffic congestion increases near the Grand Parkway, transportation engineers will look at all of those changes then make estimates and recommendations."
